
Vickery Midtown PID Mission

Vickery Midtown Overview

- Partnership with over 2,500 properties
- Funded by special tax assessment of either \$.05 or \$.10 per \$100 to provide public improvements and services
- Represents over \$1.65B taxable value

- Continued Midtown Blues Program
- Provided 7,459 hours of private patrol to augment City Services
- Track criminal activity and statistics to adjust security coverage to make the most effective use of budget
- Increased patrols on the SoPac Trail
- Continued weekly meetings with DPD regarding neighborhood crime





2020 Highlights Continued

- Began implementation of Resilience Program
- Partnership with The Bridge
- Applied for and were awarded \$150,000 seed funds from the Moody Foundation
- Coordinating with the City of Dallas to place intake manager and social worker in the Vickery Justice Center to connect those experiencing homelessness in our community with resources

Meet new DPD NE Division Chief Ismail and Major Williams for optimum communication/needs




Goals for 2021 Continued

- Alternate ways to verify info provided etc.




VICKERY OFFENSE HISTORY

- Coordinated with City of Dallas and Bond projects within the PID

Improve public space and public realm to improve pedestrian/bike comfort and safety

- Initiate Trailhead design for SoPac Trailheads
- Coordinate with City on Park Lane corridor project
- Ensure that City capital investment advances the PID's goals
- Prioritize and implement additional sidewalk and lighting improvements within the PID

Coordinate with private development to ensure that pedestrian amenities are developed in connection with projects

PID Renewal Timeline

Summer 2021: Draft petition due to OED for CAO approval

- Description of proposed services and improvements and the special benefit to property owners
- Proposed cost and method of assessment
- Proposed boundaries
- Service Plan [Estimated cost of improvements/ services for the entire term]
- NEW:
 - PID renewal terms longer than 7 years
 - E-signatures on petitions are acceptable subject to meeting City's security requirements
 - Ensure the City and the PID comply with new HB 1543 requirements

Final Petition: City-approval Petition, Map and Service Plan

October 2021-January 2022: Collect signatures



PID Renewal Timeline

February 1, 2022: \$15,000 application fee with minimum number of petition signatures/affidavits due

February 2022-March 2022: Staff petition verification

April 2022: Call for Public Hearing

May 2022: Public Hearing and Council vote to authorize PID creation/renewal, Service Plan, and management contract with management entity
